Please join us for our spring music therapy workshop presented by **Cindy Lu Edgerton, MM, MT-BC, Kellee Coviak Hansen, MS, MT-BC and Jeff Wolfe, MT-BC on Sunday May 22, 2016**. The workshop will be held at Michigan State Community Music School, 4930 S Hagadorn Rd. East Lansing, Mi 48823



The workshop will run from 9:00 am – 3:30 pm and will provide professionals a chance to earn 5 CMTE credits. This workshop will focus on available reimbursement opportunities for music therapists and funding resources available to assist with client services.

Mounting student loan debt is ricocheting through the United States, and is affecting many young and seasoned professionals. MMT will provide information on how to reduce student loan debt, access scholarships and grants available to music therapists, as well as share information on how to fund client services through the Michigan Medicaid Waiver and Insurance Reimbursement. This workshop will be centered around round table discussions so participants can gain a better financial understanding and have a chance to ask questions within a small learning community. This workshop will include writing samples, reimbursement guidelines, song sharing, discussion, and individual case examples.

Kellee Coviak Hansen, MS, MT-BC is the Founder and Executive Director of CODA Music Therapy Services, LLC in Lansing, MI. She maintains certifications in both music therapy and music education and recently completed her master's degree in special education. Mrs. Hansen is involved in leadership of numerous professional organizations, including serving as the current president of the Michigan Music Therapists and co-chair of the Michigan Music Therapy Task Force. Additionally, she has been a recipient of the AMTA Past-Presidents' Conference Scholar Award (2014), the GLR MUSE Fund (2015), the Cheryl Krul Memorial Music Therapy Award (2006), the MMT Memorial Scholarship (2005), and a Sigma Alpha Iota Music Education Outreach Grant (2013).

Jeffrey Wolfe, MT-BC is the Community Programs Manager, and a music therapist at the Institute for Therapy through the Arts in Chicago. He specializes in interventions for children and adults with neurodevelopmental disorders, adolescent mental health, and abuse survivors. He holds the Neurologic Music Therapy-Fellow certification, is a published author, and frequently presents on a regional and national level. Jeff serves as the Chair of the Student Affairs Advisor Board for the American Music Therapy Association, and serves on several local and regional committees. He is a co-founder, consultant and administrator of his family business, Kids Town Child Development Center in Brunswick, Ohio.
